WHEREAS the CCUP held a Regular Meeting on May 22nd 2013;

WHEREAS, on April 24th 2013 a building permit was delivered by the town manager of the Municipality of the Village of North Hatley for the expansion of the terrace at the Restaurant & Bistro Pilsen inc., the members of Consultative Committee on Urbanism and Heritage feel that the permit should not have been delivered, for the following reasons: the presence of the flood zone and the error of procedure.

The members of the Consultative Committee on Urbanism and Heritage recommend that the municipal council <u>decline</u> the request for the minor derogation.

WHEREAS Resolution 2013-030 regarding a request for a permit to replace the porch railings at 3010, ch. Capelton was passed with the recommendation that it be adopted by the Town Council;
