2013-08-05.07 RESOLUTION SUPPORTING LAC MÉGANTIC

AUGUST 5, 2013

WHEREAS the municipality of Lac Mégantic suffered a tragedy last July 5th caused by the derailment and explosion of a train transporting oil/petroleum;

WHEREAS this railway accident will also have long term consequences on the environment and that at this time we are unable to assess the extent of the environmental damage caused by this derailment;

WHEREAS, in the face of this tragedy, the UMQ has appealed for solidarity to all the municipalities to come to the aid of the municipality of Lac Mégantic and its citizens to rebuild the community;

WHEREAS the UMQ is asking that the municipalities make cash donations to the "Tragédie / Lac Mégantic 2013" trust fund in the name of the UMQ ;

WHEREAS the municipality of the Village of North Hatley wants to support the Municipality of Lac Mégantic;

WHEREAS it is necessary that safety standards and regulations be re-examined and tightened in order to ensure maximum safety in the transportation of hazardous materials by rail or by road;

WHEREAS hazards presented by certain materials are not well known and that emergency measures may not be adequate in the event of a catastrophe;

WHEREAS the Municipality of the Village of North Hatley wants to contribute financially to the trust fund established by the UMQ to help this community;

UPON PROPOSAL DULY MOVED BY MICHAEL MUNKITTRICK THE COUNCILLORS UNANIMOUSLY RESOLVE

THAT the Municipality of the Village of North Hatley authorize the payment of \$673 or \$1 per citizen to the UMQ as a contribution to the "Tragédie / Lac Mégantic 2013" fund to come to the aid of the municipality of Lac Mégantic which has suffered a disaster resulting from this railway accident;

THAT the Municipality of the Village of North Hatley request from the relevant public authorities, namely Transports Québec and Transport Canada, that they proceed with a complete review of the regulations concerning the transportation of hazardous materials by rail and by road in order that the transportation of such materials be done safely to prevent such catastrophes from happening again.
