ADOPTION OF BOR EST	ROWING BY-LAW 2024-01 - RÉGIE INCENDIE MEMPHRÉMAGOG
WHEREAS	the ministre des Affaires municipales, des Régions et de l'Occupation du territoire officially designated the Régie intermunicipale de prévention et de protection incendie Memphrémagog Est (hereafter: « la Régie ») ;
WHEREAS	there is the 2021-2027 planned purchase of capital asset, for the construction of a fire station to replace current fire station no 3 located in Ayer's Cliff;
WHEREAS	Resolution 2022-033 made official the request for financial assistance to the ministère des Affaires municipales et de l'Habitation within the framework of the Programme d'amélioration et de construction d'infrastructure municipales (PRACIM) acquisition plan;
WHEREAS	the current state of fire station no 3 is a major safety and efficiency issue for the Régie firefighters and equipment;
WHEREAS	the Régie has a firm sales offer for the acquisition of a section of lot 4 665 318 with a deadline of August 8, 2024;
WHEREAS	there is an electric pole to be moved on the said lot;
WHEREAS	the Régie adopted a resolution mandating the FQM to join it in submitting a request for financial assistance to the MAMH;
WHEREAS	there are legal costs related to the acquisition of the property as well as survey costs;
WHEREAS	the notice of motion and presentation of the said by-law were given at the Council meeting of February 19, 2024;
WHEREAS	Council members acknowledged having received a copy of said by- law within the delay period established by law;

CONSÉQUENTLY Council at the Régie incendie Memphrémagog Est state the following:

Article 1 Preamble

The Preamble is an integral part of the by-law.

Article 2

Council is authorized to proceed with the purchase of a lot for the construction of fire station no 3 and head office of the Régie Memphrémagog Est.

Article 3

Under this by-law, the Régie authorizes an expenditure not exceeding TWO HUNDRED AND TWENTY THOUSAND DOLARS (\$220,000.00).

Article 4

In order to meet estimated costs under this by-law, the Régie has authorized borrowing up to TWO HUNDRED AND TWENTY THOUSAND DOLLARS (\$220,000.00) over a twenty-year (20) period.

Article 5

In order to cover annual loan capital interest and repayment expenses incurred, the current by-law requires of all municipalities that are party to the agreement a contribution calculated on a cost sharing basis as outlined in the agreement, a copy of which is attached to the said by-law as Annex A.

Article 6

The Régie applies all contributions or subsidies received to the decreed loan reduction under the current by-law whether in whole or in part.

Article 7

The Régie also applies, in whole or in part to payment of the debt service, all subsidies payable over a number of years. The loan repayment terms corresponding to the amount of the subsidy will be automatically adjusted to the period set for payment of the subsidy.

Article 8 Effective date

The present by-law comes into effect in accordance with the Act.
